# Conditions of participation

The terms and conditions under which the 'Credit Expo Belgium' (hereinafter referred to as: the event) can be participated in, are laid down in the following terms and conditions of participation.

## Organisation

Credit Expo Belgium is organized by: Next Level Academy B.V. (hereinafter: 'the organization'). The address for correspondence is: Jan Vrijmanstraat 293, 1087 MN Amsterdam, The Netherlands, Phone: +31(0)20 - 672 1371, E-mail: info@creditexpo.be

## Place and time

The event will be held at De Montil in Affligem on Thursday 20 April 2023.

## Opening hours

The event is open to visitors from 09.00 to 18.00. For event partners the event will be open from 08.00 hrs.

## Meeting points

The event partners' 'meeting point' will be fully provided by the organiser (totem with logo and possibly flat screen, table for laptop, possibly hdmi cable, electricity and wifi). On 20 April between 08:00 and 09:00, the event partner's laptop can be connected to the screen by themselves (for demos and presentations). It is allowed to further decorate the meeting point with additional own marketing material (e.g. roll-up banner or beach flag), but no large folding stand. Own stand construction by the event partners is not allowed.

## Speciale activiteiten

Special activities on the meeting points, such as performances with image and sound, may only take place if written permission has been requested and obtained from the organisation at least 30 days before the start of the event. One of the conditions for granting permission is that the activity must be situated in such a way that visitors are not inconvenienced.

## Event partners

The organisations participating in the event are economically active in the credit management market or related financial services. The organisation reserves the right to refuse participants without having to justify its decision.

## Programme

Only products and services which, in the opinion of the organisation, are in line with the aim of the event to offer the public the widest possible overview of the Belgian market for credit management and related aspects, may be presented at the event. This is at the discretion of the organisation.

## Corona clause

The agreed costs for participation will only be charged when it is certain that, as a result of restrictive measures imposed by the government in response to COVID-19, there is no ban on the organisation of Credit Expo Belgium 2023. Costs made by the event partner to prepare the participation cannot be recovered from the organiser if the event would be postponed or cancelled due to the corona measures.

## Cancellation

Cancellation of confirmed participation by the event partner is not possible due to the one-off nature of the event.

## Reservation due to changes

The organisation reserves the right to change the dates and times of the event or cancel the event due to special circumstances beyond its control, as well as if the organisation is forced to do so, without the participant in such a case being able to make a claim against the organisation for compensation for any damage, in whatever form or from whatever cause this may have arisen. If the live event cannot take place due to corona measures, the organisation reserves the right to organise a digital version instead, in consultation with the partners.

## Payment conditions

Payment must be made in one instalment after receipt of the registration confirmation and invoice. The payment term is 30 days after the invoice date. If a registration is made less than 30 days before Credit Expo, the amount due must be paid simultaneously with the submission of the request for registration.

## Applicable law

Dutch law applies to all agreements and agreements resulting therefrom. All disputes shall be settled by the competent Dutch court.
