Conditions of participation

The provisions under which participation in 'Credit Expo Belgium' (hereinafter referred to as: the event) can take place are set out in the following conditions of participation.

Organisation

Credit Expo Belgium is organised by: Next Level Academy B.V. (hereinafter referred to as: 'the organisation'). The correspondence address is: Stroombaan 4 (Edison building), 1181 VX Amstelveen, The Netherlands.

Venue and time

The event will be held at De Montil in Affligem on Thursday 25 April 2024.

Opening hours

The event will be open to visitors from 09:00 to 18:00. For event partners, the event will be open from 08:00.

Meeting points

The event partners' 'meeting point' will be fully provided by the organiser (totem with logo and possibly TV screen, table and chairs, electricity and wifi). On 25 April between 08:00 and 09:00, the event partner's laptop can be connected to the screen by themselves (for demos and presentations). It is allowed to further decorate the meeting point with additional own marketing material (e.g. roll-up banner or beach flag), but no large folding stand. Own stand construction by the event partners is not allowed.

Special activities

Special activities at the meeting points, such as performances with sound and image, can only take place if written permission has been requested and obtained from the organisers no later than 30 days before the start of the event.

One of the conditions for granting permission is that the activity must be situated in such a way that visitors are not inconvenienced.

Event partners

The companies participating in the event are economically active in the credit management market or related financial services. The organisation reserves the right to refuse participants without having to account for this.

Programme

Only products and services may be presented at the event that, in the opinion of the organisation, are in line with the aim of the event to provide the public with the broadest possible overview of the Belgian credit management market and related aspects. This is at the discretion of the organisation.

Corona clause

The agreed participation fee will not be charged until it is certain that, as a result of restrictive measures imposed by the government following COVID, there is no ban on organising Credit Expo Belgium. Costs incurred by the event partner for its own preparation for participation cannot be recovered from the organiser if the event is postponed or cancelled as a result of the corona measures.

Cancellation

Cancellation of confirmed participation by the event partner is not possible due to the one-off nature of the event.

Reservation due to changes

The organisation reserves the right to change the dates and times of the event or cancel the event due to special circumstances beyond its control and if the organisation is forced to do so, without the participant being able to make any claims against the organisation for compensation for any damage, in whatever form or from whatever cause. If the live event cannot take place due to corona measures, the organisation reserves the right, in consultation with the partners, to organise a digital version instead.

Payment conditions

Payment should be made in one go after receipt of the invoice. The payment term is 30 days from invoice date. If registration is made less than 30 days before Credit Expo, the amount due must be paid simultaneously with the submission of the request for registration.

Applicable law

Dutch law applies to all agreements and any resulting agreements. All disputes shall be settled by the competent Dutch court.
